



## Donors abroad

As a donor resident in one of the European member countries or in the United States, you can make a gift to the Fondation de Montcheuil, public interest foundation, or to one of its foundation under aegis : Fondation Ginette, Fondation JES-Franklin, Fondation Saint-Joseph de Tivoli, Fondation La Providence Loyola Education, Fondation le Caousou, Fondation Massilia Ignace Education through the network TGE ([Transnational Giving Europe](#)) or for the USA, through CAF AMERICA.

Through the [Transnational Giving Europe](#), or the CAF USA, the donor, whether person or company, makes a gift to his home-country foundation which then **provides the donor with a tax receipt** and transfers the gift to the beneficiary organisation in the country partner.
